

CHAPTER I INTRODUCTION

A. Background of the Study

English was one of the foreign languages for Indonesian students that must be learned in school since kindergarten level until University level. Were the speaker being able to expressing oneself in words, making speech and then this process will get result speaking skill (Elmiyati, 2019).

Some students Junior High School ASSA' ADAH BUNGAH felt that speaking was not easy, it takes time for the students to with speaking the correct sentence. They felt distress in the use of grammar. And they also feel confused on deciding which vocabulary that they will use. The students were also confused on making sentence with a good organization. Comparing my research with the previous studied shows some similar results, when the student's speak they find difficulties in pouring the idea or notion. The

students find difficulties in speaking grammar and getting ideas, organizing ideas, developing ideas into sentence, and maintaining sentence unity (Hosni, 2015, p. 22). So, many students when speaking were still less understanding between the speaking of good and right. Therefore, the researcher assumes that the student's felt bored when they are speaking because the student's find difficulties when to decide what grammar and vocabularies they choose.

To over come this, the teacher chosen a technique of learning which encourages students to think more creative, innovative and independent because this technique is easy to speak active when the students come forward in front of the class was making spider diagram. Based on the result of the researcher that Clustering is a technique used to see a visual map of our ideas and to make us think more creatively in making new association (Muhammad Yusuf, 2007). With Clustering technique is useful to help the students to speak in English and to improve their ideas of speaking skills by applying this technique. The clustering technique is a technique for quickly making the explicit idea and associations about the topic (Titin Rahmiatin, 2001). Based on previous research the results are a visual way to see ideas and connect them with each other and make the coherent score of students taught by grouping techniques increase (Sumartini, 2018).

On the basis of the above, the researcher had a motivation to examine when The influence of clustering technique to the student's speaking achievement.
