CHAPTER I INTRODUCTION

A. Background of the Study

According to Leech (1983) Linguistics was divided into phonetics, Phonology, Morphology, Syntax, Semantics, and Pragmatics. Pragmatics was the central topics of linguistic were those aspects of meaning which are dependent on context. Pragmatic was study of relationship between linguistic form and the users. Pragmatics is included deixis, implicature, speech act and discourse (Yule, 2018). Implicature is defined as an implicit meaning implication in a speech accompanied by context, even though the meaning is not part or fulfillment of what is said. In connection with that, the essence of implicature is the hidden meaning of an utterance uttered by (Grice et al., 1976) suggesting that implicature is an utterance that implies something different from what was actually said. Something different is the purpose of the conversation that is not stated explicitly. In other words, implicatures are hidden intentions, desires, or expressions of the heart. Implicature is also interpreted as a hidden meaning in the return of the speech. In other words, when someone speaks or writes, what is said or written is not what was meant.

Language has an important function for human life, especially the communicative function. By communicating, humans can fulfill their desires as social beings who are interconnected to express their thoughts and opinions and work together. Interaction between humans can be well established because of communication that is mutually understood between them. One of the tools used in communication is language. When

communicating, humans have goals and purposes in their speech. In speech, a speaker has an exclusive intention when saying something. The meaning contained in an utterance in a pragmatic context is called implicature. Sometimes people use certain words to imply something quite different from the literary meaning says, it makes interlocutor must relate it with the outside aspect of language such as culture, believe and background of interlocutor. If this occasion happens, it may lead us to Implicature (Yulianti et al., 2022).

The concept of conversational implicature was put forward by Paul Grice (1975) in his article entitled "Logic and Conversation". Grice (1975) as cited Brown and Levinson (1987) state that the term implicature is used that in the event of speech, a speaker may describe something that interpreted, implied or intended different from what is said. The implied meaning can be either conventional or conversational. Furthermore, Grice et al (1976) classified conversational implicature into generalized conversational implicature and particularized conversational implicature. Generalized conversational implicature refers to an implicature whose meanings are inferred without specific contexts. Generalized conversational implicature is implicature that emerges without any specific setting or situation. While, particularized conversational implicature refers to an implicature whose meanings are inferred to specific contexts and it is not depending on the context but rather on spoken proposition.

In the process of communication, speakers and speech partners are aware of each other that there are rules that govern actions and govern their language. Each speech participant must be responsible for the actions and deviations from the rules of language in the interaction. Cahyati (2017) says that in normal communication it can be assumed that the speaker articulates the speech and intends for the speech partner to understand what is being communicated. For this reason, speakers try to make their speech always clear, concise, always on the subject of discussion and easily understood by their speech partners. Speakers may find difficulties in comprehending the intention of other speaker in a conversation. In an effective talk the speakers and listener are assumed to communicate effectively by producing and inffering utterances. Khairunas et al (2020) set a standard of global imperatives in producing rationally effective utterances called cooperative principle which

included of four maxims. There are the maxim of quantity: make your conversational contribution informative, the maxim of quality: be true and evidence, the maxim of relevance: be relevant with the context, and maxim of manner: avoid ambiguity.

One of the communication media that is currently trending is podcasts on youtube. In this era of information disclosure, where the public or the public are increasingly critical of the news, public services are very necessary for the media to communicate to provide clear information and according to the facts in a good and correct way so that it can be accepted by the public.
