

## CHAPTER 1 INTRODUCTION

In this chapter the researcher provides to the detail description of this research as follows; background of the study, scope and limitation, statement of the problem, purpose of the study, significance of the study, and definition of key terms. All the sections will be discussed as follows:

### **A. Background of the Study**

Lakoff (1975 cited in Lisda, 2016). She proposed the existence of the women's language. She believes that, there are some linguistics features that differentiation among men and women. In Lakoff's theory by recording a conversation between a man and women, and analyzed the differences in the way they spoke. she states that there are certain features which men and women use separately which show gender inequality, for example the way women use super polite forms such as Would you mind?. She argued that women have insecurity when they are talking (Lisda, 2016:13).

It can be interpreted, the difference in the use of language among women and men is not only caused by sexual difference. Social factor, culture, and behavior is also more important things to determine how women and men used the language in the ways of speaking. According to Lakoff, (1975) cited in Lisda, (2016) said that, there are ten aspects which make women and men different of using language. Those of aspects are: Precise discrimination, avoiding using strong expletive, empty adjectives, tag question, rising intonation, lexical hedges, intensifier, emphatic stress, hypercorrect grammar, and polite form. Therefore, sexual difference is not one massive thing, that make women and men is different in the use of language and in the ways of speaking. Through the language used can be shown and describes the peoples gender as their social identity.

In this study, *the Language Feature in Selected Short Stories Written by Female Authors in Online Jakarta Post* is chosen as the object of the research as there are many uses of language features found in it. Occasionally, the readers can see the relationship of

language and author in the short story which reflects the real life condition. Each author has their own woman language features in writing a short story. Men and women also have their own language feature in writing. In this study, researcher wanted to discuss about language features of female authors in writing short story. Besides, the researcher want to investigate what kinds of language features are used by female authors in the writing short story. Because the researcher attracted to the study object. According to the object of the study there some previous studies which give the foundation of the difference between the recent study and previous study.

The thesis belongs Cornelia Sely Amanda, and student's number 131214064. The title is *An Analysis of Women's Language Features by Hillary Clinton in Presidential Debates*.
