

ABSTRACT

Language is used differently between genders such as between man and women. They tend to use different characteristics of language on their social behavior or social communication. In relation to the language features used by different gender, this study is intended to explore the types and the functions of language features used in Malala Yousafzai's speeches.

To describe the focused problems, this study uses case study in qualitative paradigm where the data collected from Malala Yousafzai's speeches are in the forms of utterances containing some features referred to how women use language. The data can be in the forms of words, phrases and clauses. In analyzing the data, the researcher uses Lakoff's theory.

This study showed that some language features appear in the way Malala Yousafzai use the language, such as lexical hedges or fillers, rising intonations, intensifiers, empty adjectives, hypercorrect grammars, superpolite forms, avoidance of strong swear words, emphatic stress. Additionally, the function of each features are grouped generally into hedging device, boosting device and politeness device.

Bahasa digunakan secara berbeda antara gender seperti antara pria dan wanita. Mereka cenderung menggunakan karakteristik bahasa yang berbeda pada perilaku sosial atau komunikasi sosial mereka. Sehubungan dengan fitur bahasa yang digunakan oleh jenis kelamin yang berbeda, penelitian ini dimaksudkan untuk mengeksplorasi jenis dan fungsi fitur bahasa yang digunakan dalam pidato Malala Yousafzai.

Untuk menggambarkan masalah yang terfokus, penelitian ini menggunakan studi kasus dalam paradigma kualitatif di mana data yang dikumpulkan dari pidato Malala Yousafzai adalah dalam bentuk ucapan yang berisi beberapa fitur yang merujuk pada bagaimana wanita menggunakan bahasa. Data dapat berupa kata, frasa, dan klausa. Dalam menganalisis data, peneliti menggunakan teori Lakoff.

Studi ini menunjukkan bahwa beberapa fitur bahasa muncul dalam cara Malala Yousafzai menggunakan bahasa, seperti lindung nilai atau pengisi, peningkatan intonasi, penguat, kata sifat kosong, tata bahasa hypercorrect, bentuk superpolit, penghindaran kata-kata umpatan yang kuat, tekanan empati. Selain itu, fungsi masing-masing fitur dikelompokkan secara umum menjadi perangkat lindung nilai, perangkat pendongkrak dan perangkat kesopanan
